



**Availability for New Service Request Form Instructions**  
*(effective June 12, 2023)*

1. Customers inquiring on the availability of water and sewer services for a property will need to fill out and submit the attached form to the Galveston County Water Control and Improvement District No. 1 (District) Falco Office located at 2320 Falco Street, Dickinson, Texas 77539 or by email to [falco@gcwcid1tx.gov](mailto:falco@gcwcid1tx.gov). If there are any questions concerning this form, please call 281-337-7529.
2. For this request, the District will only be providing a verbal acknowledgement if water and sewer services are available at the requested property. In the event that an extension of water and/or sewer services are required for the District to service this property, the District will only provide a verbal approximation of the cost to extend services. No formal quote of utility extension costs will be provided in response to this Application. The District, at its discretion, may request a meeting with the requestor / property owner to further discuss the proposed development plans and District service requirements.
3. NOTE: This Application is NOT for requesting installation of water and sewer taps. Customers seeking taps shall fill out and submit the "New Residential Service Tap Application" or the "New Commercial Service Tap Application".
4. All property "not in the District" and desiring service from The District **must be** annexed. Only Property Owners may annex a property. The District will confirm if the requested property is within or outside the District service boundary as part of this request.
